Job outline

- Providing support to young people during the opening hours of the project; either face to face, by videolink.
- To support others who are overcoming mental health challenges in their journey to recovery and wellbeing
- To plan, promote and deliver delegated activities in accordance with the service user's needs to meet goals identified in the individual's Plan

Scope & Authority

- Peer Support workers engage with iRock service users to show empathy, share experience, inspire hope and promote recovery with the aim of assisting individuals to gain and maintain independence in the community
- Peer Support Workers are part of the iRock drop in service for YP aged 14-25.. The role is to focus on the day-to-day holistic support needs of service users. Self-managed care is essential to this: the supported person is encouraged to assess their own needs and to develop and implement a self-management plan
- Peer Support is delivered through promoting empowerment and choice and giving the opportunity for the exploration of meaning and purpose
- Supervision will be used to continuously reflect on, evaluate and develop peer approaches

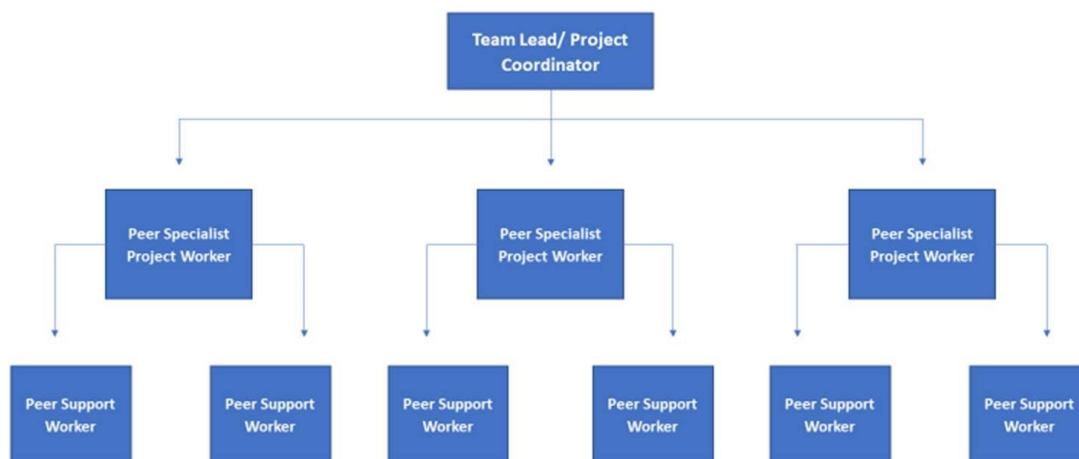

To support service users in identifying possible triggers or causes of relapse• To provide support to individuals in gaining choice, developing and managing meaning and purpose of life and independence, and maintaining dignity and self respect• To support individuals in meeting holistic needs (education, welfare, employment, financial, leisure, housing, spiritual, etc) in partnership with other individuals, care team and agencies and within a recovery environment• To promote and make service users aware of personal strengths and social networks, and highlight their ability to engage with these• To deliver educational training to service users (as appropriate)• To engage actively in peer and professional supervision and apply the learning to working with clients of the service• To support access and facilitation of hospital based (inpatient roles only) activity sessions both on a one-to-one and group basis for service users• To ensure all service users are aware of activities which may be of benefit to them and how these can be accessed• To undertake any other such duties as may reasonably fall within the remit of the post, as required by the Manager/Supervisor

Key Relationships

Contact with service users and their families and carers, mentorship from Peer Specialist Project Workers, Supervision from Project Coordinator and Team Lead.
Liaison with social services, mental health services, and third sector services. External mainstream agencies eg local colleges, school and universities, and other youth service providers.
